## **NOTICE** **RE: UPS RATES**

Please be advised that the UPS Central Pennsylvania Joint Supplemental Negotiating Committee has approved the split allocation of the \$1.00 per hour available for **August 1, 2020** under the Central Pennsylvania Supplemental Agreement.

The allocation has been determined as follows:

**1) For the UPS Participants that participate in both the Central Pennsylvania Teamsters Health and Welfare Fund and the Central Pennsylvania Teamsters Pension Fund:**

\$0.30 per hour (\$52.00 per month) to the Health and Welfare Fund  
\$0.50 per hour (\$86.67 per month) to the Defined Benefit Plan  
\$0.20 per hour (34.66 per month) to the RIP1987 Plan

In accordance with the above, the new rate under the Central Pennsylvania Teamsters Health and Welfare Fund will be:

**\$1,984.67 per month**

In accordance with the above, the new rate under the Central Pennsylvania Teamsters Pension Fund based on the \$0.70 per hour increase will be:

**\$2,417.13 per month**

This new pension rate has been allocated by the Central Pennsylvania Joint Supplemental Negotiating Committee has follows:

**\$2,087.80 per month to the Defined Benefit Plan**  
**\$329.33 per month to the Retirement Income Plan 1987**

- 2) **For the UPS Participants of Teamsters Local Unions 401 and 773 who are participants of the Teamsters Local Union No. 401 Health and Welfare Fund, the increase under the Central Pennsylvania Teamsters Pension Fund will be \$0.50 per hour (\$86.67 per month) with the new rate as follows:**

**\$2,313.13 per month**

This new pension rate has been allocated by the Central Pennsylvania Joint Supplemental Negotiating Committee as follows:


**\$2,087.80 per month to the Defined Benefit Plan  
\$225.33 per month to the Retirement Income Plan 1987**

The remaining \$0.50 per hour available under the Agreement for these Participants has been allocated by the Central Pennsylvania Joint Supplemental Negotiating Committee to the Teamsters Local Union No. 401 Health and Welfare Fund.
